**Reflections** - Kristen Allen-Bentzen, Leah Gibson, & Heather Bratton

Up and running this year.

Theme concerns. This year's theme has been triggering for some groups. Themes are chosen two years in advance by student suggestions from a nationwide search by the National PTA. The Reflections team has been in communication with the the Student Equity Group regarding this.

**Student Equity Group** - Jacob Lessing, Silvia Carias-Centeno, and Grace.

Spoke regarding concerns students have with this year's Reflections theme "I Matter Because..." in the context of this year's Black Lives Matter movement; racist incidents happening in the schools; the fear of being a student of color; and that this prompt elevates the potential of putting marginalized groups in danger. Asking that PTA to use their influence to address the underlying issue of the culture of racism in our schools.

# **District Updates** Ron Thiele

School Board Meeting tonight.

Dyslexia - parent engagement group meeting November 5.

Meal distribution - Waiver just got approved and extended to distribute multiple meals to anyone under 18. Last week ISD distributed nearly 4500 meals to students across our district. Adding breakfast increasing distribution to 10 meals/week instead of 5.

#### **HS Graduation Dates**

- June 11th for IHS, LHS, SHS (T-mobile park)
- June 10th for GEHS (Meydenbauer)

Executive Director of Communication position has been vacated as of July 1st. Hoping to have this position filled by the third week of October.

Capitol Projects - Elementary 16 and Middle School 6 are under construction and progress is on schedule to open next fall.

Comprehensive High School 4 and Elementary 17 are moving forward, but still in the site development phase with opposition from surrounding community.

Monitoring reports as a governance board will be discussed at the school board meeting tonight. Student Discipline. Starting to see nice trends in the right directions — suspensions are down, especially with students of color, special needs, and students or poverty. Two specific categories: failure to comply and disruptive behavior are down as well.

COVID and shutdown management - worked through the summer with IEA on reopening plans. Sent a letter to the community last week. Hybrid with around 9-10 students in a classroom. K students have not yet been in-person. Sending a survey out to K-3 families explaining what it will look like and asking for commitment through second trimester. Will have to reorganize some classes if students and teachers don't choose the same path (remote vs hybrid).

## From questions asked:

- Look for information after January on when the boundary for Elementary 16 & Middle 6 will be drawn and communicated. Opportunities to join the boundary review committee is typically pushed out through the buildings and also advertise through the district.
- Monitoring of COVID case rates everything will be dependent on the activity of the virus in our community. Must be prepared to transition back to fully remote. There will be a 2-3 week observation before bring in the next group.
- Looking at 4 days a week in-person using Wednesday as a full remote day (which also allows for a midweek deep clean of the buildings).
- Why is ISD slower to return Special Education students than neighboring school districts? LWSD has brought back their students. Mercer Island is bringing back individual students need based, Bellevue is bringing back students soon. ISD worked with IEA and did in-person hybrid summer school. It is complex and varying health care needs of this student population.

- Will follow up regarding the Merlin programs having Reflections as an art requirement and lack of volunteers. The Student Equity Group is more than willing to support that conversation about the Merlin and their Reflections program requirement in any way they can. Superintendent Thiele invited them to reach out at any time.
- Transportation is a complex issue. Conversations with IEA to figure out more details. The goal is to keep neighborhoods together as much as possible when creating the bus routes for returning to in-person school. Discussions are happening now.
- Ventilation systems at the schools: Maple Hills is getting a new system as part of their
  construction. What has been done is running the systems harder an increase of the volume of
  the systems to perform a complete air replacement much quicker. Increased filtration to
  higher than required standard. It is not HEPA as that would begin to break our ventilation
  systems. Most buildings have had upgrades. During the smoke, were able to stop pulling in
  outside air, and worked very well.
- Opening of outdoor fields for use: Fields need to be mindful of not doing things that encourage large gatherings. ISD does not have a way to monitor and enforce gathering requirements. No timeline now, but is dependent on virus numbers. KingCo Governor's Phase 3 is when sports activities can begin resuming again, based on the Decision Tree.
- Furloughed bus drivers and food service workers which means they are still available and receiving compensation and health benefits. Reduced paraprofessionals. Child care has been happening in ISD since March (about 275 elementary age students). Some paras have been recalled. Down about a thousand students across the system. Looking at the possibility of a reduction in force of certificated staff in the spring.
- The district has purchased a variety of masks including N95s & fitting kits for staff and cloth masks for students (2 per student). Guidance is constantly being updated. Hand sanitizer, additional sanitizing stations, touch-less thermometers, and gloves. Will need to continue procurement.
- ISD does not expect volunteers back in the buildings this year. Hoping to be able to get volunteers back in later in the school year, but it all depends on virus mitigation.
- Building filtration questions referred to the Capitol Projects for details. Executive Director Martin Torney is the best person to ask. turneym@issaquah.wednet.edu
- Special Education Funding: Has there been any change in how federal funding ISD has
  accepted for special education is used? ISD received and used CARES funding and used it to
  procure PPE. Much of Special Education money does not come from the federal government.
